July 20 th	Show & Sell orders due online. FULL cases only
August 1 st through December 21 st	Online Popcorn Sales
August 8 th	Show & Sell pick up day
August 10 th Tradeshow of Scouting	Program Kick Off, Training, Pick up Take Order sales materials
September 12 th	Take Order / Show & Deliver sale begins
October 7 th	Last date to qualify for the Friends of Scouting "Fair Share" commission
October 9 th	50% RETAIL Show & Sell payment due in office
October 12 th	Units can start to place Take Order & Return Show & Sell Popcorn
October 24 th	Last day to return unused Show & Sell Popcorn, no later than 3:30 pm. After that a 40% restocking charge will be assessed
October 26 th	Take Order sale and prize orders due online
October 27 th	Home Delivery sign-up sheets due in office (No grace period)
November 9 th	Take Order sale pick-up times and locations emailed to kernels. Invoices are final and available for viewing online.
November 14 th	Take Order sale pick-up day. PAYMENT IN FULL IS DUE BY THIS DAY
December 11 th	Absolutely last date to submit prize orders online and supplemental prize orders (\$750 club, etc.)
December 11 th	Last day to Exchange Take Order popcorn. Any Exchanges after that are subject to a 40% restocking charge.
