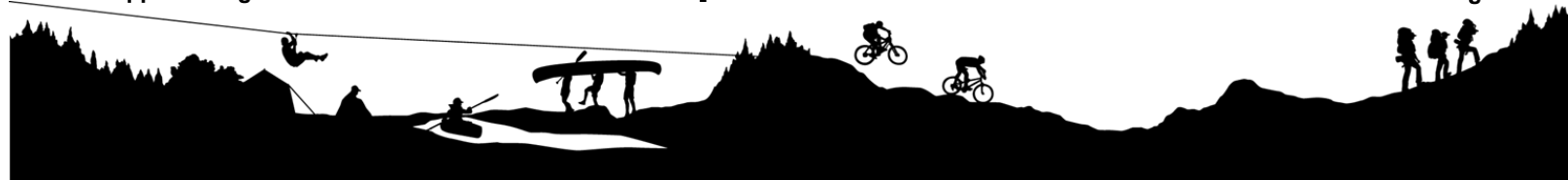

Rules For Use

- The unit leader will receive an email from Square with a link to create a POS account.
- All users will need to download the Square Point of Sale app.
- Access to the account is by the email address (from the front page) and password (created by the leader).
- The unit leader responsible for the equipment will be trained by PPC staff.
- The unit leader will instruct the adult leader in charge of the Show and Sell location in its proper use and share the email address and password used to set up the account.
- The Square Readers WILL ONLY be used by the adult leader in charge of the Show and Sell sale at that location.
- At no time are youth allowed to handle the Square Readers.
- All monies received for credit card sales will be electronically transferred into a PPC bank account.
- PPC will pay the credit card processing fees.
- PPC staff will run a report once per week and credit the sales to the unit's invoice in Camp Masters.
- All accounts will be deactivated by November 1, 2021.
