## WOODSMAN'S THONG

**Patriots' Path Council, B.S.A.**

To: All Participants

Please help the staff be able to better serve you on this training course by following the rules below.

1. **No Fires.** We do not plan on having the necessary fire-suppression equipment in the campsites, and fires should not be necessary.
2. All **lights out** and the campsite **quiet** 30 minutes after dismissal at the close of the program.
3. We are enforcing the **two-deep leadership** and **Youth Protection Guidelines** at all times.
4. No Scout is permitted to share a tent with an adult under the direction of the new Youth Protection Guidelines. Adult leaders and scouts are to tent separately. Youth sharing tents should be no more than two years apart in age. A full detail on all Youth Protection Guidelines are found in The Guide to Safe Scouting under "Barriers to Abuse" section.
5. **Bears** in the campsite - participants are to stay put and follow instructions given during the program.
6. NO food is allowed in the campsite - no snacks, no candy in tents or packs. Leave all food in a locked vehicle (there is no reason to bring food with you).
7. Please stay out of the kitchen. It is crowded enough with the staff working to provide your meals.
8. Scouts which are unaccompanied by an adult will be paired with a buddy and assigned to a staff member.
